The Roustan United Arena Solutions Team announces CEO

Johnstown, PA – February 22, 2008 - On February 21, 2008, NIKE, Inc. (NYSE:NKE) announced that it has reached a definitive agreement to sell its Bauer Hockey subsidiary to an investor group lead by Kohlberg & Company and Canadian businessman W. Graeme Roustan for \$200 million in cash. Nike expects the transaction to be completed before the end of its current fiscal year.

In anticipation of assuming the role as Chairman of Bauer, W. Graeme Roustan will be transferring the duties of Chief Executive Officer of ROUSTAN UNITED ARENA SOLUTIONS TEAM on March 1, 2008.

Scott Branovan, currently the President and Chief Operating Officer, will assume the new combined role of President and Chief Executive Officer, effective March 1, 2008. Roustan will remain as Chairman and owner of the company.

Branovan has been with affiliated with Roustan and Roustan Capital since April 2004 assuming the role of President and Chief Operating Officer of the Roustan United Arena Solutions Team in July of 2006. Branovan has more than 20 years as a consumer products executive and brings a wealth of experience in sports marketing, brand development, market strategy and execution as well as organization management. Scott received his BA in Business Administration from Lakeland College, Sheboygan, WI in 1982. An outstanding athlete, he has since been inducted into the Athletic Hall of Fame for participation in both tennis and football. He is also a graduate of St. John's Northwestern, Delafield, WI where he was the Athlete of the Year and was later elected to the Athletic Hall of Fame, having participated in football, tennis and basketball. He also has three children that play ice hockey.
